The Improper Payments Elimination and Recovery Improvement Act of 2012 (IPERIA) and Recovery Auditing Act (Section 831 of the Defense Authorization Act for Fiscal Year 2002 (Pub.L. No. 107-107)) requires federal agencies to review programs and activities they administer and identify those that may be susceptible to erroneous payments.
